Academic Audit Report:

1. Syllabus copy must be signed by both faculty and HOD of the department. Maintain a separate page for syllabus of each subject.
2. No. of absentees and signature of the faculty must be recorded in the blue book
3. Teaching plan needs to be signed by both faculty and HOD.
4. Teaching plan period will be 45 hours (unique).
5. Textbooks must be included in the syllabus.
6. Textbooks or Reference books specified in the teaching plan must be numbered.
7. Book References in the teaching plan must be given as T1, T2 or R1, R2. Complete name of author, name of the book, publishers, are not necessary.
8. Strictly follow Bloom's taxonomy while preparing for both internal assessment and end semester questions.
9. Content beyond the syllabus also need to be incorporated. If the no of hours to be handled is 45 hours. Additional 3 hours has to be added to deliver content beyond the syllabus.
10. Question paper and answer key has to be prepared for all the three internal tests.
11. Rather than giving typed assignments, hand written assignments have to be given to the students.
12. Update the term objective into objectives as there is more than one objective.
13. Avoid short forms for the name of the subjects.
14. The subject title must be general and not be specific like Artificial Intelligence for games.
15. Web resources or sources of information to be removed from the Teaching plan.

4. For the 1st Year B.Tech, more remedial sessions can be conducted to improve the programming logic.

Hereby I have verified 79 course files for the odd trimester/semester for the period July 2015-January 2016. The overall rating of the documentation is good. Some observations are noted below

Observations of the Audit

1. All faculty have followed most of the teaching learning process with sincerity.
2. The quality of test questions papers is OK
3. The valuation of the tests and assignments are fair
4. The blue book has been mostly filled in, though many did not enter the syllabus coverage notings and many have failed to obtain director's signature and its missing
5. Most files do not have the forms (4, 5, 6A, etc), placed in order and many forms are incomplete
6. Some faculty have not filled in first pages of test papers when correcting the papers.

Suggestions to improve the Academic Audit:

1. The forms can be made online for ease of compiling and have e-documentation done.
2. All faculty may be asked to file the forms in the beginning of the files in a sequential order.

Report on Academic Audit

We have audited about 75 files of the Department of Mechanical Engineering on February 6, 2016. The following observations were made.

1. In general, it was observed that standards maintaining here are on par with the high ranking institute.
2. In one or few Blue book register, the internal marks entry was not carried out properly.
3. Time Table entry and the class coverage entry have not been completed in Blue Books.
4. In some cases it was found that the quality assessment marks entered in the Blue Book is not matching with the consolidated printed one.
5. Since the test marks is not entered inside the test papers, it is not possible to audit the valuation process.
6. In the end semester question paper, some of the drawings are not clear (example Engineering Mechanics)
7. Some of the question paper may include sub division instead of giving a full question for 20 marks.
8. Few end semester questions are of below standard when compared to the Test Question paper.
9. Quality assessment valuation is generally liberal.
10. In few of the Blue Books, Quality Assessment marks are not entered. Hence could not be verified.

1. All files are maintained properly. However all columns are to be filled in / or deleted. Syllabus plan /coverage mismatch to be avoided.
2. Laboratory records are maintained properly some of the lab manuals are not attached.
3. Answer sheets are well evaluated.
4. Quality Assessment has been done using assignments/seminars /viva properly balanced.
However seminar presentation topics are not given.
5. Standard of questions can be slightly improved.
6. Self-study topics can be given to the students.
7. Assignments can be graded with difficulties and can be given to the students.

6. Literature survey for Electron Devices & Instrumentation (14EC2019) is not needed for 3rd year students.
7. Lab observation, lab record and Lab manual for Microprocessor lab & Microcontroller lab are missing in course file.
8. Indirect questions may be asked for end semester lab exam.

3. Laboratory simulation questions need to be a bit challenging.
4. Open source softwares like SCILAB shall be taught to students as a value added course.
5. Digital control of power converters can be included for PG students..

Some of the positive aspects of the academic audit:

- The staffs have improvised the standard of Question paper setting which was commented in the previous audit.
- Proper Course file maintenance.
- Staffs have followed innovative practices in choosing Quality assessment parameters.

Suggestions given by the external expert:

- In laboratories the observation and record books have to be signed by the concerned staffs with date
- For Quality assessment (MINIPROJECT) proper proofs have to be documented.
- It will be preferable if the question paper have application oriented questions than action verbs.
- Since it is mandatory to handle 45 hours for 3 credit paper and 60 hours for 4 credit paper, the staffs have to follow the same. If not compensation classes have to be taken.

Thank you very much for the nomination as Expert member for academic audit in the Department of Nanoscience and Technology and Department of Physics at your esteemed institution on 8.3.2016. I have gone through both CBCS and non-CBCS course files of both above mentioned departments. In addition to the individual file evaluation remarks, I'd like to submit the following general comments and/or recommendations for your kind reference.

- (1) If the teaching plan contain the details of "Content beyond Syllabus", will not only be benefitted for the students but also to bridge the gap between curriculum POs. For example, we can update the current research trend on that particular topic or social awareness which is related to the subject. It can be taught either by video or interactive session or discussion. Web links can also be utilized which should be mentioned in the teaching plan.
- (2) NPTEL/MIT/Course video lectures can be utilized to extend of coverage on topics as mentioned in the syllabus. So that the students can have better basic knowledge and future idea on the subject.
- (3) The answer key for the internal test question paper can be displayed for a day (from as soon as the test starts) for the students benefit and for the transparency as well.

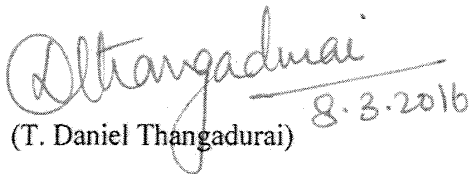
- (4) After every semester examination, the faculty can submit a feedback on that particular course stating about what are all the benefits/advantages that students received because of this subject and how to improve it in the future semesters.
- (5) The file content should be in order as per the check list and maintained uniformly in the whole department. For example, the consolidated internal mark list was missing in few files.
- (6) Please mention the Unit wise information in the teaching plan. In few files it was missing as well as lab manuals too.
- (7) For the benefit of the students, the laboratory observation should be hand written. So that the student can remember what he/she has done during the practical classes.
- (8) The unit wise course material (PPT & video lectures) can be stored in DVD to attach in the course file.
- (9) Mapping of COs with POs is very much appreciable.

Finally, if an auditor found an incomplete course file(s) (for example, without end semester question paper) and try to give some suggestions and/or recommendations to concern faculty, he/she should NOT argue as if what they have done is correct. In addition to that he/she should NOT insist to auditor what to write as remarks.
