2. Answer script

• In most of the courses, corrections are carried out in a fair manner and the marks awarded are also in unbiased manner.

4. Suggestions for Improvement

- Appropriate questions can be asked in each part/section to enable the student to perform well in the examination.
- Question paper should be answerable by an average student, at the same time some critical thinking type questions can be asked to explore the capability of the top creamy layer students.
- Questions can be asked to differentiate the average, and meritorious students. Each Question Paper consists
 - o A1. 60% of questions set, shall be answerable by all students with good preparation
 - A2. 20 % to 30% of questions set, shall be answerable by hardworking students i.e. average students and
 - o A3. 10% to 20% of questions set, shall be answerable only by hard working and bright students who refer to all the material available i.e. above average students.
- Case study / application type questions can be asked to explore the skills (practical / application) by the students especially in elective subjects.
- Case study questions can be properly framed with the consideration of syllabus content.
- Questions coverage can be given on additional topics beyond the syllabus content (especially for higher semester subject/electives)
- Blooms taxonomy can be given importance with the level of knowledge.
- Repetition of same / similar taxonomical verbs can be avoided in all type of questions.
- Importance can be given to concept based questions while setting up of question paper.

5. Laboratory

- Laboratory observations may be recorded in separate note book (not in Manual)
- Experimental procedures must be written in passive voice in the laboratory record
- Separate rubrics can be developed for the laboratory assessments
- Observation note / Record note book must be written with significance of the results obtained from the experiments.

General comments:

• The system of academic audit is quite robust and the contribution of IQAC and Department faculty in ensuring its smooth implementation is commendable.

 Many course files contain papers with zero marks. Though we ask Faculty members to keep answer scripts of low, medium and high performing students, it reflects poorly about the program when we show an empty paper in course file.

On Course Outcome

- The course outcomes need to be formulated carefully. Certain Courses have only one CO (eg. FEM) and for certain courses the CO dent reflect the course content (eg. Mechanics of Solids, mechanics of Fluids, Mechanics of machines)
- CO attainment computation is to be done for lab courses also. This is essential because certain
 POs can be attained only through lab courses and their attainment can be ascertained only
 through these course outcomes.
- CO Attainment target for many courses are fixed as 100%, which is synthetic

On Program Outcomes

- As NBA and NAAC is talking about PSO along with PO, the whole exercise will be complete if we add 2-3 Program Specific Outcomes for each of the programs
- The system of CO PO mapping is done by faculty members. In many cases the faculty members have attempted to map COs to all 12 POs which is conceptually wrong. This

problem can be avoided by formulating CO – PO&PSO mapping by a small team of senior faculty at the department level

• CO-PO mapping must be same for courses with same course code

On Course Syllabus

- M. Tech level theory and lab courses need to be designed in such a way that they are substantially at a higher plane than the B. Tech counterparts (eg. Mechatronics and Automation Lab advanced Vibrations Engineering Lab)
- While designing lab courses for M. Tech programs different from
- Mechanics of solids Course is having certain important missing topics. Probably mechanical department can be asked to frame its own syllabus different from Civil Engineering course.

General:

1. Detailed workshop can be conducted for the faculty to understand on how to map the various outcomes.

Theory subjects:

- 1. Higher Order Thinking skills questions can be introduced in the question paper.
- 2. Question paper should have atleast one question (either conceptual or numerical) related to realtime applications.
- 3. Blooms Taxonomy can be used as a guideline for setting the questions.
- 4. Tutorials be made mandatory and slot allocated in the time table for subjects which are considered highly numeric in content.
- 5. Separate monitoring and assessing mechanism is required for the slow learners.

Laboratory Experiments:

- 1. Faculty in charge of the lab shall conduct experiments, collect data and do the analysis. Lab manual shall be prepared by him/her.
- 2. Apart from the list of experiments given in the syllabus, few experiments over and above what has been given should also be incorporated and conducted.

The overall feedback could be stated as satisfactory. A summary of the audit was given under 3 subdivisions.

1. Areas of excellence

- Detailed Evaluation procedure for quality assessment was mentioned.
- Action taken for failures were stated.
- Grade analysis graph was generated.

2. My observation of the course files

- Topics covered (as mentioned in software) is not correlating with teaching plan (mentioned through excel). Faculty members lack clarity in configuring the number of sessions.
- Topics completion summary was inappropriate, since in most of the course files the summary was provided as few topics of syllabus was not taught, which implies full syllabus was not covered by the faculty. For instance, in topics completion report of 14CS2007, handled by Mr.S.E.VinothEwards, it is mentioned as only 26 topics was covered out 51, which is unacceptable. If the University was not functioning for few days, then those days should be removed from the teaching plan and faculties should be provided options to edit the topics in the software.

3. Areas of improvement

- Day wise topic coverage was declared in system generated 'topics covering details' and 'teaching plan', which is redundant.
- Answer keys of internal assessment tests can be provided.
- If more than one faculty member is teaching a course, then minutes of the meeting is necessary to document the discussion of topics for internal assessment 1, 2 and 3.

- Only few faculties have substantiated with support documents for action taken for failures.
- Feedbacks from students have to be collected for each course and faculty. Faculty's response for the feedbacks should be remarked.
- Course outcomes for lab courses can also be defined and attainment can be measured.
- I recommend adding lab exercise questions in course files.
- If e-record is followed then uploads of students for each exercises can be filed as sample copies.

The following are few of the points that are observed during the academic audit of EEE department in Karunya Institute of Technology and Sciences.

- 1. Even though bloom's taxonomy is followed by all the faculty, few of the areas need improvement while framing questions. Typos, unnecessary usage of capital letters, not using prepositions and using first person sentences needs to be corrected.
- 2. Few of the faculty use the unit conventions wrongly. For example,
 - i. KVA should be kVA
 - ii. KVAR should be kVAR
 - iii. wb/m2 should be Wb/m2
 - iv. AM/PM should be am/pm
- Common question paper such as Basic electrical and electronics can be discussed and framed together by the faculty involved, thereby grammatical errors while framing of question paper can be avoided.
- 4. Few reasoning/scenario based questions can be posed to students to improve their thinking ability.

Overall the audit is satisfactory and quality of academics has improved a lot as compared to auditor's previous visit.

- 2. The lecture schedule should be made from the reference book cited in the syllabus and if the reference book is not available show the test book ref. accordingly.
- 3. The mid-term exam should be conducted on 45th working day.
- 4. Adoption of uniform pattern of question paper is needed.
- 5. Course no. 17AG1007 Principles of Genetics and Genomics: The reference books cited in the syllabus is not related to the books used in teaching plan references. Also in the teaching plan, in courses like 17AG1007, only http:agrimoon is mentioned. Similar thing was observed in all the courses.
- 6. Course no. 17AG009 Dimensions of Agricultural Extension: Request to shift the course to final year of the degree programme. Similarly course no. 17AG1008 Agricultural Economics may be taught after 5th semester onwards. Having this course at first year level will lead to the failure of this course.
- 7. Improvement in teaching plan is needed.

- a. Try to avoid power point presentation in I or II year and the quality of some of the ppt shown in the teaching file is not relevant.
- b. Periodic evaluation of the syllabus by the students will certainly improve the curriculum of the degree programme.

- Scrutiny report duly signed by the scrutinizer and the question paper setting faculty may be added in the course file.
- For common question papers, scrutinizer should be a faculty not handling that course.
- Use quantifiable verbs for CO preparation. Better to use Blooms taxonomy.
- For Statistics related courses QA may be improved by incorporating techniques in data analysis, industry visit etc. with due credits given.
- Use Power Point Presentations for statistics teaching material
- Attendance record is not provided for many Course files.
- 100% attainment of COs is observed in some courses which is unnatural.
- Teaching material provided must be of better quality and must be prepared by the teaching faculty from different sources rather than providing photocopy from standard textbooks.
- Rather than MCQ and Assessment tutorials more techniques may be adopted for quality assessment especially in courses related to statistics.
